Subject: Minutes of Meeting of Consultant Selection Committee (CSC) for Re-evaluation of Technical Proposals in Light of Grievance Submitted by M/s Epsilon Technologies (WASH Project)

A meeting of the Consultant Selection Committee (CSC) was held on 19 December 2025 at 2:00 PM in the Committee Room of the Directorate, under the chairmanship of the Project Director, Project Management Implementation Unit (PMIU) – Rural Growth Centre (RGC), PRS. The meeting was convened to re-evaluate the technical proposals in light of the grievance submitted by M/s Epsilon Technologies regarding the non-consideration of one relevant WASH project during the technical evaluation of bidders uploaded on EPADS.

2. The CSC re-examined the WASH-related project experience of M/s Epsilon Technologies, details of which are enumerated below:

- i) Consultancy Services for Design Review & Construction Supervision for Water Supply, Sewerage, Drainage & Wastewater Treatment Projects in Newly Merged Districts (NMDs), Khyber Pakhtunkhwa, amounting to **PKR 218.32 million**.
- ii) Consultancy Services for Water Supply Schemes / Rehabilitation / Sanitation in Thana Khas, Thana Bandajat, Malakand Khas, Audand, Dherai, Palai, Dheri Julagram, Totakan, Pirkhel, Agra, Upper Batkhela, Middle Batkhela, Lower Batkhela and Tehsil Dargai, District Malakand, amounting to **PKR 83 million**.
- iii) Sanitary Sewerage System with Treatment Plant for Gilgit City (PMC Services), amounting to **PKR 76 million**.
- iv) WASH Component Consultancy under the Disaster & Climate Resilience Improvement Project (DCRIP), amounting to **PKR 81 million**.

3. Previously, the CSC had been awarded 15 out of 20 marks for relevant experience. However, in light of the grievance, it was mutually agreed to consider the supervision component of one of the WASH project, namely *Consultancy Services for Design Review & Construction Supervision for Water Supply, Sewerage, Drainage & Wastewater Treatment Projects in Newly Merged Districts (NMDs), Khyber Pakhtunkhwa*, amounting to PKR 218.32 million. As the design component was not undertaken by the firm, it was decided to consider 50% of the allocated marks for this project.

4. The summary total revised scores of the firms/consortia are as follows:





Subject: Minutes of Consultant Selection Committee (CSC) Meeting for Technical Evaluation of Proposals – Package-2, RGC Chachro, District Tharparkar

A meeting of the Consultant Selection Committee (CSC) was held on 17 December 2025 at 2:00 PM in the committee room of the Directorate, under the chairmanship of the Project Director, Project Management Implementation Unit (PMIU) – Rural Growth Centre (RGC), PRS. The meeting was convened to evaluate the technical proposals submitted on 11 December 2025 by interested consulting firms/consortia for the Design, Supervision, and Monitoring Consultancy Services for Package-2 of RGC Chachro, District Tharparkar.

2. The CSC conducted a detailed examination and evaluation of the technical proposals submitted by the following firms/consortia:

- i) RCC Consultants
- ii) CGD Consultant Pvt. Ltd.
- iii) EMC Pakistan Pvt. Ltd.
- iv) Epsilon Technologies
- v) B.M. Consulting Engineers Pvt. Ltd.
- vi) CG Consultants Pvt. Ltd. in JV with Ensibo Pvt. Ltd.

3. The evaluation was carried out strictly in accordance with the criteria specified in the RFP, comprising 20 marks for specific experience relevant to the assignment, 20 marks for adequacy of the proposed methodology in response to the Terms of Reference, and 60 marks for qualifications and competence of key professional staff, totalling 100 marks.

4. Initially, the eligibility criteria outlined in the RFP were assessed for all bidders. It was observed that M/s B.M. Consulting Engineers Pvt. Ltd. did not meet the requirement of having an average annual turnover of not less than PKR 100 million for the last three years, duly certified. Additionally, in the case of CG Consultants Pvt. Ltd. (Lead Firm) in JV with Ensibo Pvt. Ltd., the lead firm was found not to be registered with PEC, which is a mandatory requirement. Consequently, both firms were declared ineligible for further technical evaluation.

5. The Committee reviewed and evaluated the technical proposals of all participating firms against the approved evaluation criteria, including relevant experience, adequacy of the proposed methodology and work plan, and qualification and competence of key professional staff, with a total allocated score of 100 marks. The total scores of the firms/consortia are as follows:
